

Privacy Statement

Dübör Nederland B.V. (hereinafter referred to as: "Dübör"), having its registered office at the De Kreek 10 in (4906 BB) Oosterhout, always provides for the safeguarding of the privacy rights of the persons whose personal data it processes. Hence, Dübör handles collected personal data confidentially and shall in all instances comply with the requirements that the current privacy legislation imposes on the same.

Personal data

Dübör only collects personal data that were expressly and voluntarily made available to the same. The information consists of, inter alia, (business) name and address details, gender, telephone number, email address, website, bank details.

Dübör processes the aforementioned personal data because this is required for the implementation of the agreement concluded by and between Dübör and the buyer of its products. Dübör can also process personal data if it is required to do so by law.

Dübör can process personal data on the basis of a vital interest, a general interest or a justified interest. Dübör informs the data subject accordingly. If the personal data were not obtained directly via the data subject then Dübör shall inform the data subject of the source from which the personal data originate.

Purposes

Dübör shall only use the personal data for the purpose for which they were made available. Dübör processes personal data, inter alia, in connection with the sale of products and service activities.

Retention period

Dübör shall not retain the supplied personal data longer than required for the purposes for which they were collected.

Contact details of the Data Protection Officer (where applicable)

Rights of data subjects

The person whose personal data are being processed is - barring statutory grounds for exception – entitled to request Dübör for information and/or rectification and/or erasure of the personal data and/or protection of the relevant processing.

In addition, the data subject is entitled to object to the processing and Dübör must transfer the data of the data subject - following their request. Dübör shall comply with the aforementioned requests within one month, unless this cannot be required of the same within the aforementioned time limit, for instance due to the relevant complexity.

If the processing of personal data is based on consent of the data subject then the data subject is always entitled to revoke the consent. The data subject is entitled to submit a complaint to the relevant regulatory body, i.e. in the Netherlands the Data Protection Authority.

If the information / personal data were not obtained from the data subject then Dübör informs the data subject of the source from which the personal data originate and, as the occasion arises, whether they originate from public sources.

Data exchange with others

Dübör shall never make personal data available to third parties, unless this is required for the implementation of an agreement, it is required to do so by law, it has a justified or general interest in doing so, or it expressly obtained consent to do so. Dübör shares, if it is entitled to do so, personal data with own employees.

Dübör uses cookies when offering electronic services. A cookie is a simple small file that is sent with pages of this website and that are stored by your browser on the hard disk of your computer. Dübör uses cookies to remember settings and preferences of the users in order that it can, inter alia, be tracked what pages are being visited and to thus create a profile of the online behaviour. The cookies can be deactivated via the browser.

Dübör informs the data subject if it exchanges personal data with a third country and/or international organisation. In this respect, it shall in any case provide information about the level of protection of the relevant country (adequacy decision or other appropriate guarantees) and how a copy can be obtained. Dübör exchanges personal data within the own organisation only.
